Saint Philip House, Inc. provides access to safe and affordable housing while rendering support services with dignity to individuals living with HIV/AIDS who are at risk of homelessness and their loved ones. Community awareness of AIDS prevention is accomplished through education while empowerment is encouraged for all. Since its inception in 1989, over 150 clients have received the benefit of direct services. Their ages have ranged from 1 to 65. Immediate family members of all ages have also received supportive services from the program.

St. Philip House scored 97% in the annual AIDS Resources Connecticut (ACT) Program Audit. This annual audit is required by the CT Department of Housing. The audit team consists of: an independent ACT auditor and representatives from HUD, the State of Ct. Department of Housing, and the City of Hartford HOPWA program. The audit team inspects and reviews all aspects of the program's operations and also meets with a client focus group.

During the fiscal year ending on September 30, 2015, St. Philip House maintained a 95% occupancy. We currently oversee 24 apartments/homes that house 41 individuals: 14 women, 13 men and 14 children. The Saint Philip House van provided approximately 975 trips for medical appointments, meetings, counseling sessions, client shopping trips and program recreational activities. The house monitor also uses the program van to take client shopping for groceries or personal items. Rental and utility assistance was given to 100% of the households served by the program. Based on client case files, case managers provided 18,950 units of case management to clients during this fiscal year.

At minimum, St. Philip House offers two recreational activities per month to all clients and families. These activities ranged from lunch and a movie to miniature golf and attending area points of interest including the Yankee Candle Shop, and the Eastern States Exposition in Massachusetts. St. Philip House staff and volunteers prepared holiday and special meals at the facility and clients, staff and friends enjoyed them.

Extra program support is given to the children involved with the Saint Philip House program. New clothes and backpacks to start the new school year were given to each school-aged child. Holiday gifts are also given to each child in the program.

Educational Assistance was offered to fund continuing education for both clients and their families.

St. Philip House sponsors a monthly facilitated HIV support group open to anyone in the HIV community. Also open to anyone in the HIV community are massage therapy reflexology.

St. Philip House now offers free and confidential HIV testing on the 2<sup>nd</sup> and 4<sup>th</sup> Tuesdays of each month in collaboration with HRA Human Resources Agency) of New Britain.

**AIDS Prevention Education and Outreach**

An integral piece of our program is our award winning educational component. We are fortunate that our educational programs have been supported through generous corporate and community grants and private donations. This year St. Philip House staff and residents educated students through presentations and workshops for area school systems, churches and civic groups as well as local colleges such as Tunxis Community College and Lincoln College.

St. Philip House worked in conjunction with Mazzarella Media to produce 2 HIV prevention DVDs. One targets high school and college age students and the other reaches out to the senior citizen population. Mazzarella Media will market the DVD nationally.

Saint Philip House continued its affiliation with its sister organization La Posadita del Buen Pastor. in Lima, Peru. Our monthly pledge greatly assists this home for orphaned and abandoned children with HIV/AIDS. In fiscal year 2014-2015 we allocated \$2400 to this program from our fund raising efforts.
